



BOARDING CONTRACT

I, _____, agree to the following relative to my dog's care at Adorybull Groom and Board, LLC.

1. I agree that my dog is current with the following vaccinations: Rabies, DHLPP, and Bordetella. I will keep the vaccines current while my dog is in the care of Adorybull Groom and Board, LLC (Kennel). I authorize my veterinarian to release all information regarding the status of vaccinations for my dog. I further understand that even if my dog is vaccinated for Bordetella (Kennel Cough) there is a chance that my dog can still contract Kennel Cough. I agree that I will not hold AGB responsible if my dog contracts Kennel Cough. _____(initials)

2. I understand the Kennel requires fecal testing and agree that we can contact your pet's Vet for their health information. _____ (initials)

3. I authorize Kennel to arrange emergency veterinary care, releasing Kennel from all liabilities relating to transportation, treatment, and expense. Should my specified veterinarian be unavailable, I authorize Kennel to engage the services of a veterinarian of its choice. If I cannot be reached in a timely manner, I authorize Kennel to approve medical and/or emergency treatment as recommended by a veterinarian. I will reimburse Kennel for any expenses incurred. _____ (initials)

4. If my dog is boarding, in the event of a minor injury, such as an ear bite or small puncture wound, I would like Kennel to handle this without contacting me or my emergency contacts. In the event of a major emergency, I want to be contacted directly. _____(initials)

5. I understand that it is required that my dog is on a flea control program. If any fleas are found on my dog, I authorize Kennel to treat my dog for fleas as deemed necessary by flea bath and/or flea treatment application. I understand that I will be contacted prior to any treatment, and I am responsible for the cost of such services. _____ (initials)

6. I (or my homeowner's insurance), will be responsible for any injury (i.e. dog bites or scratches requiring medical attention) to Kennel principals, employees, agents, or representatives, due to my dog's actions or the condition of my house/premises. _____ (initials)

7. I agree that if my dog is the cause of any injury or death to another animal or the cause of damage to the property at 12535 Buffalo Road, Clayton, NC 27527, I shall be fully legally responsible for the cost of any such injury, death, or damage. I agree to fully indemnify Kennel, its principals, employees, agents, representatives, successors, and assigns for any costs, losses, or legal expenses incurred in the defense of any personal injury or any other claims, including claims for negligence, brought by myself or a third party arising from or related to my actions or the actions of my dog while on the premises or in the custody of Kennel. **I have read this paragraph and understand the consequences of any aggressive/destructive behaviors of my dog.** _____(initials)

8. I understand that Kennel needs to monitor our noise level in the neighborhood. I further understand that if my dog creates a disturbance with constant/continuous barking, Kennel reserves the right to use a citronella (not shock) bark control device or program on my dog as necessary. I have read and understand this and understand the importance of discouraging constant/continuous barking. _____(initials)

9. I understand that Kennel encourages dogs to socialize, exercise, and that like children on a playground, I fully realize that illness/injury can reasonably be foreseen when a group of dogs are playing together, even when supervised. Kennel's sole responsibility with regard to my dog is to act with reasonable care. I agree that if Kennel acted reasonably, I shall not bring any claim, suit, or action of any kind against Kennel arising out of the illness, injury, or death of my dog (whether such illness, injury or death is discovered while the dog is in custody of AGB or afterwards). I also realize that the fences at AGB are approximately six feet high and I understand that if my dog has the ability to jump/ climb a fence of this height, I am liable if my dog escapes. _____ (initials)

10. Adorybull Groom and Board, LLC requires a \$50.00 deposit for Christmas reservations and a \$25.00 deposit for all other holiday boarding. The deposit is applied to the boarding fee at checkout. Clients have until December 15 to finalize their Christmas reservations. After this date the client is financially responsible for the entire reservation. A list of holidays requiring a deposit is available upon request. _____(initials)

11. Occasionally grooming can expose a hidden medical problem or aggravate a current one. This can occur during or after grooming. I have read and understand this. If your pet is severely tangled or matted, it is at greater risk of injury, stress, and trauma. All precautions will be taken to avoid this. I have read and understand the possibility of a nick or clipper burn during grooming. _____(initials)

12. I authorize Adorybull Groom and Board, LLC to maintain my credit card on file and charge purchases and/or services rendered against the card at the prices in effect at time of the transaction. I understand that I am able to request a statement or written invoice at any time and that the majority of business communication is done via email. If my e-mail addresses change, I will notify AGB. _____ (initials)

13. I understand that I am responsible for payment of all boarding and grooming fees and any additional costs incurred by the kennel, including authorized veterinary costs, at the time the animal is released. If I do not pick up the animal within five days of the day we agree upon, we may assume the animal is abandoned and you authorize us to dispose of the animal as we see fit. You realize that you are still obligated to pay the full amount of the bill. You also agree to pay a finance charge of 1.5% per month (18% per annum) and any and all collection or attorney's fees incurred by us relating to your non-payment. _____(initials)
